Mission Statement

Basic High School challenges students to pursue their individual learning goals while preparing themselves for the future.

Principal's Highlights

Basic High School has a proud tradition of excellence in academics, fine arts, athletics, and activities. It is a school where student learning continues to be the primary focus.

- AYP data indicated a substantial reduction in non-proficient students for the whole school in English (23%) and math (20%).
- We completed an extensive self-study for Northwest Accreditation and formulated a five-year action plan to accomplish goals.
- The graduating class of 2006 received over \$2,646,000 in scholarship money for a 119% increase over the previous year.
- We expanded our AVID program and our small learning communities of Law, Health, Arts, and Business Technologies.
- "We the People" Govt. Honors class won the district competition and competed at state level for the last 8 out of 9 years.
- MCJROTC program again earned congressional recognition and received Honor School designation for the sixth consecutive year.
- We instituted a monthly mentoring program to support academic and personal growth, pairing each student with an adult mentor.
- Columbia Scholastic Press Association has awarded our nationally recognized El Lobo Yearbook its top honors six times.
- We continued partnership with Nevada State College's Dept. of Nursing to operate our school-based health center.

Goals and Objectives

Goal 1

Students across all subgroups will show increased achievement in mathematics on the Nevada High School Proficiency Exam.

Objective(s):

Students will show an increase in performance as measured by the NHSPE in mathematics. At the end of one year, spring 2007, students will show a 10% increase in identified mathematic content strands.

Goal 2

Students across all subgroups will show increased achievement in English on the Nevada High School Proficiency Exam.

Objective(s):

Students will show an increase in English Language Arts (ELA) performance as measured by the NHSPE. At the end of one year, spring 2007, students will show a 10% increase in identified ELA content strands.

Goal 3

The average daily attendance rates across all subgroups will be increased.

Objective(s):

At the end of one year, the school will achieve an overall attendance rate of 91.8%, an increase of 1.5%. The average attendance rate for students with IEP's will increase by 1.5%, from 87.9% to 89.9%. The average attendance rate for the Black subgroup will increase by 1.5%, from 88.6% to 89.9%.

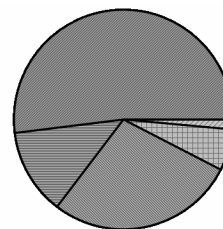

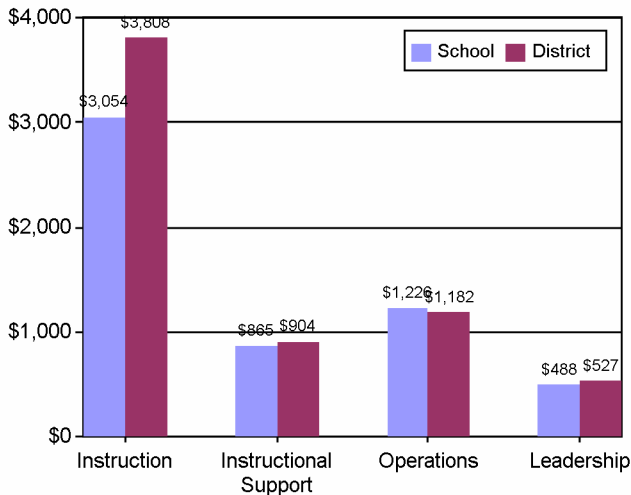

Parent/Community Involvement

Basic High School maintains an open line of communication with parents and members of the community throughout the school year. Meetings are held to provide information about school curriculum, classroom instruction, student achievement, and extra-curricular activities. Some examples include: monthly Parent Advisory Committee meetings, Open House, Junior Jump Start College Night, Financial Aid Nights, Eighth Grade Parent Information Night, Freshman Barbecue and Orientation, AVID Parent Night, field trip parent informational meetings, Senior Awards Night, National Honor Society Induction Ceremony, student activities, and sports banquets. Community members, parents, and students regularly attend Advisory Council meetings held for the Law, Justice, and Public Service Institute and other smaller learning communities. Intouch Online gives parents and students the ability to review grades and attendance and email teachers with questions. Newsletters are sent to parents every other month with news of student achievement, student recognition, and school activities. In addition, flyers, postcards, letters, and surveys are sent home to parents to announce important events and to gather input for the Northwest Accreditation process.
